Supervisor Mahus informed board members that he is waiting to see what the status of the \$50,000.00 grant for work at Dansville Recreational Park that was obtained by Senator Cathy Young is due to her resignation from the Senate.

Board members were informed that the Clerk and highway crew are working on leaks in the roof in the courtroom and assessor/code office.
