Whereas, both travel related cases and community transmission of COVID-19 have been documented in New York State and are expected to continue, and

Whereas, in an effort to lessen the spread of COVID-19 through person to person contact in the general population (especially seniors) the governor has changed sections of Real Property Tax Law, Section 459-c allowing the Town to grant to the assessor ways to cut down on the in person contact between the Assessor and the general population, and

Whereas the present executive order is in effect through January 17, 2021, when it will be reviewed by the Governor's office, now therefore be it

Resolved, that subdivision 7, 7-a and 8 of Section 459-c of the Real Property Tax Law, and subdivision 5, 5-a, 5-b, 5-c and 6 Section 467 of the Real Property Tax Law, to the extent necessary to permit the governing body of an assessing unit to adopt a resolution directing the

assessor to grant exemptions pursuant to such section of the 2021 assessment roll to all property owners who received that exemption on the 2020 assessment roll, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons. Provided however, that the governing body may, at its option, include such resolution procedures by which the assessor may require renewal application be filed when he or she has reason to believe that an owner who qualified for

the exemption on the 2020-assessment roll may have since changed his or her primary residence, added another owner to the deed, transferred property to a new owner or died, and is it further

Resolved, that powers granted in this resolution by the North Dansville Town Board to the North Dansville Town Assessor shall be in effect immediately following the passage of this resolution.
