Supervisor Dennis Mahus called the regular meeting of the North Dansville Town Board to order at 7:00 PM. Roll was taken and found Councilperson Horr, Schwenzer, and Bacon present. Councilperson Infantino was absent. Highway Superintendent MacWhorter was also in attendance. Guest: David Roberts (UH) and Jeff Miller (media).

Pledge to the Flag followed.

Deputy Town Clerk presented the minutes from the April 09, 2019 regular meeting, copy on file. A motion by Councilperson Horr and a second by Councilperson Bacon to accept the minutes as presented. All in favor. MOTION CARRIED.

Bid opening for 1996 Ford L9000 6-wheel dump truck with side wing and front plow frame: One bid from: Robert Mahany placed the only bid in the amount of \$6,111.11 for the 1996 Ford L9000 6-wheel dump truck with side wing and front plow frame. Board members feel that the truck might be worth more than the amount offered. A motion by Councilperson Horr and a second by Councilperson Schwenzer to reject the sole bid from Robert Mahany in the amount of \$6,111.11. All in favor. MOTION CARRIED. Further discussion: Highway Superintendent MacWhorter states that he can place the truck on the on-line Teitsworth Auction site with a minimum reserve amount and could also put the old zero turn mower with the truck. A motion by Councilperson Bacon and a second by Councilperson Horr to place the 1996 Ford L9000 6-wheel dump truck with side wing and front plow frame plus the surplus zero turn mower on the on-line Teitsworth Auction site with a minimum reserve amount for both items. Union Hose Tractor Pull: Dave Roberts updated the board on the Union Hose annual tractor pull on June 08, 2018 at Dansville Municipal Airport. There will be no fireworks this year. Proof of insurance for the event will be presented to the Town Clerk, prior to the event.

Airport: Supervisor Mahus brought the board up to date on the timeline and process for the repair to the main hangar roof at Dansville Municipal Airport.

Mahus presented information on the main hangar door and the final check payment. Board members reviewed the proposal that was received from Ted Zabinski, Airport Manager of South Albany Airport, Selkirk NY for the purchase of the old Dansville Municipal Airport beacon tower. The amount offered was \$500.00 and included the buyer to remove and transport the tower to the Selkirk Airport. Board members did not accept the offer and took no action on it.

Recreation Park (Dansville Rec. Park): Supervisor Mahus stated that the request for a 90-day extension on the SAM Grant would not be a problem.

Supervisor Mahus informed board members that he has been in contact with Norm Gardner, Principal Associate at Clark Patterson Lee (CPL) about engineer design services for the proposed expansion of the Town's Frontage Rd. Park (Dansville Recreation Park). The letter sent from Gardner to Mahus listed the scope and cost for the design work that will be done. The proposed cost budget estimate for the design work will be \$19,500.00, but the scope of work will be billed based upon actual time and subconsultant costs, with no mark up on subconsultant fees.

Whereas, after submitting this requested to our NYS representatives it was stated that we needed to change the request to "North Dansville Veterans Memorial Highway" from Dansville Veterans Memorial Highway" as there is a Town of Dansville, located in Steuben County, and

Whereas, this issue has been talked about in the community for several years and Whereas, community members in attendance gave their support for the request and

Whereas, the Town of North Dansville would like to place signs at the north town line and south town line proclaiming this section of highway "North Dansville Veterans Memorial Highway", now therefore be it

Resolved, that with the passage of this resolution the Town Board does, with a great deal of pride, designate Main St (State Rte. 63) in the Town of North Dansville "North Dansville Veterans Memorial Highway" and be it further

After some discussion; A motion by Councilperson Bacon and a second by Councilperson Schwenzer to allow the Dansville NYS Farmers Market to use the parking area located at 50 Maple St. every Friday from May 24, 2019 - October 04, 2019 from 11:30am until 04:30pm. All in favor. MOTION CARRIED.

A motion by Councilperson Horr and a second by Councilperson Infantino to pay all bills as audited, General Account Vouchers #92-#112 incl., totaling \$58,441.45, Highway Account Vouchers # 32-#41 incl., totaling \$3,824.70 and Airport Account Voucher #2 totaling \$3,668.50.
