Charles Perkins asked what elected officials positions would be open in the fall of 2021 and who might be running for re-election. Clerk Wolfanger responded that his position will be on the ballot, but he would not be running again.

A motion by Councilperson Bacon and a second by Councilperson Infantino to adjourn. All in favor. MOTION CARRIED
